- 3.1 Team Up Presentation: Representatives from OSBA, COSA, OEA, OSEA joined members of the Canby School Board, Superintendent, parents and staff in discussion of COSA's Team Up Project. Canby will serve as one of two pilot schools across the state this spring and will assist in the development of materials that can be used by districts throughout Oregon who want to engage their communities in the budget process and in developing a positive perception of Oregon's public schools.
